St Margaret' Church, Ifield Parish 200 Club Community Lottery Rules 2023

The Rules of the Lottery are as follows:

- 1. The "200 Club" will be operated as a Community Lottery under the provisions of the Gambling Act 2005 and is licensed by Crawley Borough Council. It is also registered with the Diocese of Chichester.
- 2. The Promoter will be the Parochial Rector of St Margaret's Church, Ifield. The Promoter reserves the right to amend the rules of the "200 Club" from time to time, as may be necessary. A 200 Club administrator will be appointed by the Promoter to administer the lottery and a copy of the current rules are available from the Parish Office or on the Parish website.
- 3. All profits made by the "200 Club" will be used to support the maintenance and preservation of our Grade 1 listed church.
- 4. The Lottery will be limited to 200 members over the age of 16 years.
- 5. Participants may apply to join the 200 club by completing the prescribed Application Form. The subscription will be £10 per month, payable by standing order on the 1st of the month, or annually in a single payment of £120 made by the 1st June. On receipt of a single annual payment or a standing order form, the applicant will be allocated a Draw Number. For each additional £10 paid per month an additional Draw Number will be allocated.
- 6. A draw will take place every month for cash prizes. Winners of prizes will be notified by e-mail or post, and the results of the draws will be published in the Parish newsletter and on the Parish website.
- 50% of the total annual subscriptions will be paid out in the form of cash prizes; for this purpose, the Club "year" will run from 1st June to 31st May. Prizes vary according to the number of subscribing members.
- 8. The draws will be conducted by the Rector in front of the parish congregation at the conclusion of the first Sunday service of each month.
- 9. No "200 Club" participant will be included in the draw if the appropriate subscription has not been received prior to that month's draw. The Promoter reserves the right to reallocate any number where payment has not been received on time.

- 10. Prizes will be paid by bank transfer to the person holding the winning number.
- 11. In the event of there being less than those 200 participants, prizes shall be awarded on a pro rata basis of the actual number of members at the time of the draw.
- 12. Participants should notify the 200 Club Administrator (Mr K Lawler) in writing of any change of address.
- 13. Participants can cancel their entry in the Lottery at any time by giving one month's written notice to the Promoter (and if paying by Standing Order, they should also advise their bank). Any decision by the Promoter to wind up the Club will also be by one month's written notice. Under no circumstances can any payments be refunded.
- 14. The rights conferred by membership, including the right to participate in the monthly draw, may not be transferred.
